# **TEMPORARY JUNIOR SHIPPING POLICY OFFICER**

<u>Seas At Risk</u> is a Brussels-based NGO campaigning for the protection and restoration of the marine environment. Together with its 30+ members from all over Europe, it works to make sure that life in our seas and oceans is abundant, diverse, climate-resilient, and not threatened by human activities.

We are looking for a **Temporary Junior Policy Officer** for three-four months to join our Shipping Team. Reporting to the Shipping Policy Director, you will support Seas At Risk's policy work on the One Planet Shipping initiative.

### **Key Responsibilities**

- Contributing to the development and implementation of SAR's shipping advocacy,
  particularly in respect of the development of a compelling vision of a future shipping system
  that is aligned with planetary boundaries and social justice, and action to halve ship climate
  impacts by 2030, including:
  - Monitoring EU and international policy developments.
  - Drafting of position papers, policy briefings and reports, and organisation of workshops and events.
  - Establishing working relations with relevant government and EU policy-makers and other stakeholders from the shipping and port sector, and promoting SAR policy.
  - o Representing SAR is various forums.
  - Collaborating with SAR members and other environmental NGOs and civil society organisations, providing technical and political advice and supporting the coordination of activities to influence EU and international decision-making.
- Supporting SAR identify and deliver impactful media and communication activities.
- Supporting SAR's fundraising, writing grant proposals, and reporting to funders.
- Contributing to the development of SAR policy on the basis of objectives and strategies agreed by SAR's General Assembly.
- Contributing to other work areas when needed.

### What We're Looking For

- Relevant university degree or equivalent.
- Excellent writing and editing skills in English (additional languages are a plus).
- Strong strategic thinking and project management skills.
- Experience of policy development, preferably within the NGO or environmental sector.

- Solid understanding of EU institutions and marine/environmental policy is an asset.
- Ability to work both independently and collaboratively in an international team.
- Commitment to SAR's mission and values.
- Experience working in coalitions and supporting strong networks and relationships with EU institutions, NGOs and other relevant stakeholders.

#### What We Offer

Seas At Risk offers the opportunity to work in a growing NGO with a stimulating, informal, flexible and multicultural working environment. The post is based in Brussels, full time, with contract of three-four months duration dependent on qualifications and budget availability, to start as soon as possible. We offer a competitive salary (pay range extends from 3023.49 EUR to 3189.22 EUR gross depending on relevant experience), coupled with various benefits (including holiday bonus, luncheon vouchers, working from home and representation allowances, contribution to public transport, and equivalent of 32 days paid leave per annum).
